

Application for Exemption from Curriculum Framework

Application Process

- Under Section 11 of the Curriculum Council Act 1997 education providers may be granted exemption by the Minister for Education and Training from the requirements to implement the Curriculum Framework, as detailed under section 10 of the Act.
- Applications for exemption are to be made in writing on the form provided.
- Where schools or education providers are administered by a school system, applications for exemption will be assessed at the system level prior to being approved for submission to the Curriculum Council. This means that schools that are part of the Catholic and Government school systems must forward applications via:
 - Catholic Schools – Assistant Director Curriculum Support
 - Government Schools – Director, Standards & Moderation
- Exemptions will be considered when education providers can demonstrate that they are unable to engage students in learning opportunities that will enable them to achieve particular outcomes in the *Curriculum Framework* for religious, cultural, moral or other similar reasons.
- An exemption panel will assess applications for exemption and will make recommendations to the Minister for Education and Training. Applicants will be notified when their applications have been received, and will be notified of the outcome of their application usually within six weeks of the lodgement date.
- Data submitted in support of applications will remain confidential and will not be communicated to parties outside of those involved in the assessment of applications.
